- June 10, 2025 notes were accepted as written.
- Seed Framework (AJ/CD/CM). The group discussed the draft document and shared ideas about how best to proceed at this time. Seed is a complex topic with many components (bio-regions, microclimates, pests, etc.) and the challenge is how to structure the project. Members discussed current work by the seed task force convened by an organic trade organization and the creation of a database. A member suggested that having a detailed overview of the seed supply and an understanding of the larger picture would be helpful to tease out which parts the NOSB could undertake. She also asked if a technical report would be feasible given the topic. Members contributed various ideas and feedback such as focusing on seed breeds and the certification process, commercial availability searches, and possibly hosting an expert panel. The CACS anticipates this will be a long-term project and will work on small segments.
- eCommerce labeling (KS/KD). The lead summarized the petition, which requests that the "certified by" statement on organic labels is required to be displayed on websites. The group discussed FDA jurisdiction, which governs e-commerce labeling, as well as USDA enforcement authority, given that many of the operations are exempt. The group also discussed the trademark of the USDA organic seal as well as how this might dovetail with Strengthening Organic Enforcement (SOE).

- June 3, 2025 notes were accepted as written
- Residue Testing (KS/ADB). The lead summarized the three topics that were addressed in the last discussion document on Residue Testing for a Global Supply Chain: Regulation Review. The lead suggested that two of the topics (§205.671 exclusion from sale & §205.2 definition of UREC) are clear enough that the Subcommittee will be able to include it in a proposal for the fall meeting. The other topic (related to § 205.670 (certifiers testing 5% of operations at their own expense) is complex, so the subcommittee agreed to split that topic off into a separate document, to be presented as a discussion document as the fall meeting. The discussion document may also address issues related to public availability of test results.
- **Risk Based certification (KS).** The lead is analyzing comments from the spring meeting and is confident the CACS will have a proposal for the Fall 2025 meeting. Components they are considering, include whether to be more definitive about using a common OSP, how they can include risk criteria, so they are fluid and flexible without being too restrictive, and modifying the proposed definitions slightly. The CACS's document referred to risk criteria from a best practices document from a non-public Accredited Certifiers Association, so the Subcommittee will think about where/how to publish them. The lead will incorporate feedback from the group into the next iteration of the document and the CACS will discuss this on its next call.

- Seed Framework (AJ/CD/CM). The co-leads discussed various aspects of a framework that the Subcommittee could use to approach their work on seed issues. They could categorize the issues into 4 "buckets": commercial availability definition (with focus on "quality"); access to information about variety availability; handler requirements; and intellectual property. They could also organize themes, benefits, and barriers of each issue across various stakeholder groups: seed producers; crop producers; seed distributors; certifiers. They talked about leaving room for innovation, along with wanting more organic seed (ultimately aiming for 100%), as well as other factors such as quality, variety, disease issues, pest issues, environmental issues, purity, consistency, consumer demand, and consumer facing attributes. One member briefed the group about what she learned regarding the database system used in the European Union(EU). The Chair suggested next steps for the CACS discussion document, including listing the pros and cons of the EU database system, and compiling a list of burdens and barriers for each "bucket" of issues for each stakeholder group. The CACS will discuss the draft discussion document on the July call.

- **Spring Meeting Debrief.** The CACS Chair opened the floor to comments and feedback from members. Members expressed appreciation for the Food Technologist, and the weekly bundles of written comments. Members shared techniques for reading comments, and talked about prep for the Fall meeting.

- February 11, 2025 notes were accepted as written.
- NOSB Chair update.
 - The Spring NOSB meeting is postponed, and will be rescheduled. The Chair noted that she is encouraged by the transparency, and will strive to get information to the Board members and the public.
 - The meeting materials should be posted soon, even though the meeting date yet isn't set.
 Once the rescheduled meeting date is determined, the docket will open, and stakeholders can submit comments.
 - The Fall meeting should be on track for November. Depending on when the Spring meeting gets scheduled, it could be a short turn around time.
 - \circ The NOSB Vice Chair will lead the March 18 Executive call, as the Chair will be travelling.
 - The NOSB will continue to move projects forward. In support of that, the NOP will build the templates for the Fall 2027 sunsets, and gather the list of substances for the 2028 sunsets as well. The Subcommittees will compile the list of TR requests for the 2028 sunsets to submit to NOP by June.
- Organic Seed Growers Conference Debrief (CM).
 - A member provided background and a summary of the Organic Seed Alliance's (OSA) Organic Seed Growers Conference, which was held in Oregon last week. The conference is held biennially, and there were about 450 in-person attendees, and 300 virtual attendees. The schedule included many pre-conference meetings focused on organic seed usage, excluded methods, consolidation, and intellectual property (IP), among others. Seed growers expressed frustration due to lack of revenue, and indicated that they are dropping varieties because production can be laborious and costly, organic certification is burdensome, and demand is not high enough. The NOSB is working on projects to address these issues.
 - Last week the National Organic Coalition & Organic Seed Alliance also held a listening session with organic farmers regarding organic seed costs. OSA heard from the seed producers and seed buyers about the challenges. Members added perspectives about organic seed from certifiers and growers.

 A member added that it could be helpful to identify crops where there is less harm, for example perishable vegetables vs. grains. The group agreed, while also acknowledging that seed is a vast topic and parsing it into segments might be difficult. A member shared the link to the State of Organic Seed Report, which breaks down the demographics such as organic growers, producers, etc.

• Work Agenda Check in

- The Spring 2025 agenda includes documents related to current CACS work agenda topics including a proposal on risk-based certification, and two residue testing documents (one focused on updates to the regulation and one on the NOP guidance).
